Administrative/Biographical History

In 1945, general reorganization of state government formed an Industrial Development Division of the Tennessee State Planning Commission. In 1953, this division became an independent agency known as the Tennessee Industrial and Agricultural Development Commission. The work of that commission combined six years later to form a new Department of Conservation and Commerce. In 1963, the General Assembly placed state-level industrial development under a new staff division in the Governor's Office. The General Assembly incorporated the division's work in 1972 into what is now the Department of Economic and Community Development.
